

Houston Citycam Sweepstakes Rules

NO PURCHASE REQUIRED TO ENTER OR WIN.

1. Eligibility: The Houston Citycam Sweepstakes (the "Sweepstakes") is open only to legal residents of the 50 U.S. (or D.C.) who are 18 years of age or older at the time of entry. Employees and non-employee workers of, Fancam (Pty) Ltd ("Fancam"), Partners 451, 1331 Lamar Street, Suite 510 Houston, TX 77010 ("Host Committee"), Houston NFL Holdings, L.P., d/b/a Houston Texans ("Texans") and their respective parent companies, subsidiaries, affiliates, and agents and those prize providers and agencies that are involved in the development or execution of this Sweepstakes or any of its materials, and the immediate family (spouse, parents, siblings, and children) and household members of each such person are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

3. Agreement to Official Rules: By participating in the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters related to the Sweepstakes.

4. Promotion Period: The Sweepstakes begins at 12:00 a.m. Eastern Time ("ET"), January 23, 2017 and ends at 11:59 p.m. ET, February 13 2017 (the "Promotion Period"). Fancam's computer is the official time-keeping device for this Sweepstakes.

5. How to Enter:

During the Promotion Period, visit <https://houston.fancam.com/2016/> and follow the links and instructions to locate the applicable game and then to complete and submit the registration form including a valid email address.

Once registered, follow the links and instructions to find the hidden football(s).

For every football located and clicked upon, you will receive one (1) entry into the Sweepstakes.

Limit: Nine (9) Sweepstakes entries per person during the Promotion Period.

Multiple entrants are not permitted to share the same email address.

Any attempt by any entrant to obtain more than nine (9) entries per prize by using multiple/different email addresses, identities, registrations or logins, or any other methods will void that entrant's entries and that entrant may be disqualified from the Sweepstakes. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, sweepstakes entry services) will void all entries by that entrant. In the event of a dispute as to any entry, the authorized account holder of the email address used to enter will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being authorized account holders.

6. Drawings: Administrator is an independent judging organization whose decisions as to the selection of the potential winners are final and binding. On or about February 15, 2017, Administrator will select the names of the potential winners in a random drawing of all eligible entries received during the Promotion Period. The first eligible person selected shall be the potential winner of the Grand Prize; the next eligible person selected shall be the potential winner of Secondary Prize #1; the next eligible person selected shall be the potential winner of Secondary Prize #2; etc. The potential winners will be notified by email. The odds of winning a prize depend on the number of eligible entries received for the particular prize during the Promotion Period.

7. Requirements of Potential Winners: Potential winners must continue to comply with the Official Rules. Winning is contingent upon fulfilling all requirements. Each potential winner will be required to provide full contact information, including a valid mailing address (P.O. Boxes are not permitted) within 5 days after notification or attempted notification or he or she will forfeit the prize. In the event that a potential winner of any prize cannot be contacted, forfeits the prize, if he or she is disqualified for any reason, or if prize or prize notification is returned as undelivered, Administrator will select an alternate potential winner in a random drawing from among all remaining eligible entries for the applicable prize, up to 3 alternates. If the alternate potential winners are disqualified, the applicable prize will not be awarded. Prizes will be fulfilled approximately 8 to 12 weeks after the conclusion of the Sweepstakes, with the exception of the Grand Prize, which will be fulfilled within the 2017 NFL season.

- One (1) Houston Texans gameday experience including two tickets to a 2017 Houston Texans home game (TBD by Houston Texans), one parking pass, two pregame sideline passes and the opportunity to be on the sideline for kickoff. Approximate Retail Value (ARV): \$1,000

- #2: One (1) football autographed by Johnathan Joseph – ARV \$250
- #3: One (1) mini helmet autographed by Brian Cushing – ARV \$150

Each winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes). All costs and expenses associated with a prize acceptance and use that are not specified herein as being provided, including but not limited to lodging, transportation costs, meals, gratuities and other expenses incurred by accepting a prize, are the sole responsibility of the applicable winner.

9. Publicity: Except where prohibited, participation in the Sweepstakes constitutes entrant's consent for Sponsor, Administrator and their designees to use entrant's name, likeness, prize information, city and state of residence for promotional purposes in any media without further consideration, and subject to the Administrator's Privacy Policy (<http://fancam.com/fancam-terms-and-conditions-privacy-policy/>)

10. General Conditions: In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but, not limited to, fraud, virus or other technical problem, the Administrator may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) cancel the Sweepstakes and award the prizes in a random drawing from among all eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, the Administrator reserves the right to seek damages from any such person to the fullest extent permitted by law. The Administrator's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

11. Release and Limitations of Liability: Except where prohibited, by participating in the Sweepstakes, entrants agree to release and hold harmless the Host Committee, FanCam, the Texans and their respective parents, subsidiaries, affiliates, promotional partners, prize partners, agents and agencies, and the officers, directors and employees of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized

human intervention in the Sweepstakes; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Sweepstakes or the processing of entries; (e) late, lost, or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt of any prize. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes and in no event shall the Released Parties be liable for attorneys' fees.

Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages. If, for any reason, an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Sweepstakes entry, if it is possible. If the Sweepstakes, or any part of it, is discontinued for any reason, Administrator, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any prize offered herein. No more than the stated number of prizes will be awarded. In the event that production, technical, seeding, programming or any other reasons cause more than the stated number of prizes as set forth herein to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes by a random drawing among all legitimate, un-awarded, eligible prize claims.

12. Disputes: Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by a court in Houston, Texas and (b) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering any Sweepstakes, but in no event attorneys' fees. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Texas, without giving effect to any choice of law or conflict of law rules (whether of the State of Texas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Texas.
